



## Enhancements

### 1. Improved Activity Log Visibility

All Business users listed in **Order Details** now have access to the complete **Activity Log** under **Notifications** while an order is in a status other than **Closed**.

### 2. Notary Assignment in Order Lobby

The most recent Notary user designated in **Order Details** will display in the **Order Lobby** under the **Notary** column. This allows for changes to notary assignments to be easily identified from within the **Order Lobby**. If there is not a designated Notary, the column remains blank.

### 3. Ability to Remove Signers from Order Details

Signers added to **Order Details** previously could not be removed once the **Invite Participants** button had been selected. Signers can now be removed from the **Order Details** after the account invitations have been sent. Any tags associated with a removed individual will be deleted. This functionality is available if the removed Signer has not yet signed any documents and prior to the order reaching **Pending Closing** status. Once the order has reached **Pending Closing**, Signers cannot be removed from the **Order Details**.
