Remote Witness Information

- The Remote Witness functionality differs from the In-Person/Generic Witness option.
- Remote Witness is considered a business role in Pavaso, meaning they will access the signing via Digital Close Enterprise.
- The Remote Witness creates a Pavaso account.
- The Remote Witness goes through Knowledge-based Authentication (KBA) and ID validation.
- The Remote Witness functionality is available only for Remote Online Notarization* (RON) signings.
- The Remote Closing and Video eNotary checkbox needs to be selected for the Remote Witness option to appear under the Additional Party Section in Order Details.
- Users that have used the system as Buyer and Seller Signers in the past cannot be added as Remote Witnesses.
- Users already in Order Details cannot be added as Remote Witnesses (e.g. the Closing Agent or Lender in Order Details cannot also be added as a Remote Witness under the Additional Parties section).
- Remote Witnesses cannot be removed once added to the order.
- If a user already exists in the company, then the Witness role is added to their existing role.
- A Company Admin marked as a Remote Witness cannot conduct the closing for that order.
- Lender integrations only:
- If a payload is submitted without being marked as a RON payload and includes Remote Witness information, that information is discarded.
- If a RON payload is submitted with Remote Witness information and tags are assigned to them, the tags will appear properly and will not need modification.

Note: Not all integrations support the Remote Witness role.

Remote Witness Access and Notification

- Notification is sent to the remote witness when the Signer(s) are invited to the order.
- Remote Witnesses see the most recent order association at the top of the Order Lobby.

• Remote Witnesses cannot edit/view Order Details, access Pre-Closing Review phase, Access Closing Setup phase, or edit documents.

• Remote Witnesses lose access to completed orders and do not see them in their order lobby after they are closed, unless existing permissions apply.

Example: If the Remote Witness is an Admin of the order-owner company, they will retain access to the order to the level of their admin rights.

• A Company Admin marked as Witness in Order Details cannot conduct the closing.

The Remote Witness completes the system test. This confirms camera, microphone, and speakers are operational. If the system test is completed in advance, it will need to be completed again before entering the signing.

Note: If Chrome is the selected browser, a plugin will need to be installed.

The Remote Witness will need to confirm their Date of Birth and Last 4 of their SSN. Once all required fields are filled in, Select **Continue**.

Once the DOB and SSN are complete, the Remote Witness will need to complete security questions. Select **Continue**.

Note: They will have 2 minutes and 2 attempts to complete this step and answer 4 of 5 questions correctly. *Note*: Closing agent has the option to skip this process.

Note: If they do not pass the KBA/security questions after both attempts, they will be locked out for twenty-four (24) hours and must wait to try again.

Note: The Remote Witness cannot proceed until the Closing Agent has begun the session.

As the Closing Agent begins the session, the Remote Witness will be prompted to validate their ID. Valid forms of ID are:

- Government-issued passport
- Government-issued driver's license
- Government-issued identification card

Note: Closing agent has the option to skip this process.

The Remote Witness selects the ID type from the drop-down, enters their phone number, then selects **Continue**.

The Remote Witness will receive a text message and capture the front and back of their chosen form of ID.

Remote Witness Closing View

The Remote Witness will view the Closing Agent's screen. This includes all documents visible to the Closing Agent and the webcam feeds of participants.



When the Remote Witness is sent a document to sign, they will have to share their screen. They need to give permission by selecting **OK**.

Remote Witness Tags During Signing

The Remote Witness selects the appropriate tag.



A pop up for signature and initials will show. The Remote Witness must:

- A. Fill out the Full Name and Initials fields.
- B. Draw a signature and initials.
- C. Select Save.

Adding a Remote Witness During Signing

If the Remote Witness added during order configuration cannot attend the closing or an additional Remote Witness needs to be added during a closing, the Closing Agent selects **Invite Participant**.



The Closing Agent enters the email address of the Remote Witness and selects Invite Participant.

Note: The new Remote Witnesses must go through ID Validation and KBA/security questions before entering the session. Follow the same steps listed above for the first witness.
